This year's Annual Conference was held on 21st October 2014

The Key note speaker was Maggie Atkinson Children's Commissioner for England

Maggie's presentation 'Working Together for the Rights of the Child' was described by many delegates as 'inspirational'.

The role of Commissioner had been strengthened by the 2014 Children and Families Act; it now includes a wide range of priority areas crossing the spheres of education, social and custodial care.

November 12th 2014 (Universal Children's Day) marked the 25th anniversary of the UN ratification of the United Nations Convention on the Rights of the Child (UNCRC); this highlighted the importance of focusing attention on the fundamental rights that children and young people (CYP) have.

Maggie emphasised the importance of Article 12 of the Convention – that, in accordance with their ages and stages of development, all children have the right to say what they think should happen and have their opinions taken seriously. She challenged us to think that this means far more than just 'participation' – but encompasses many other principles enshrined in the UNCRC articles.

Many reports have been produced, including the Chief Medical Officer's Annual Report 2012 'Our Children deserve better: prevention pays' – which stresses the prominence of CYP as central to health policy and practice. It urges the system to create a new Health Deal – a vision for purposefully engaging CYP in THEIR health services.

Maggie recognised that considerable progress has been made in ensuring the voice of the child influences both *policy* and *practice* – but there is still much to do.

In her 2013 report, out of 102 local health plans, only 28% actively involved CYP – and many did not mention them – confirming the view that in many areas CYP are still a 'Cinderella' group.

Maggie concluded by urging 'bravery' on the system – to make participation real and truly reflecting the values enshrined in the UNCRC.

Annual Conference - Continued:

Presentation from Emma Rigby: Working in partnership to improve young people's health

Emma is CEO of the Association for Young People's Health (AYPH). Her organisation's work bridges the world of policy, practice and evidence – to promote better understanding of young people's health needs.

She presented many useful facts, for example, young people aged 10-24 make up 19% of the population and that three quarters of mental health problems start before the age of 24.

Emma also summarised some of the challenges which had come out of the 2013/14 report from the Children and Young People's Health Outcomes Forum (CYPHOF). Many of these confirmed the issues that Maggie had presented, particularly that 'system leaders' need to ensure the principles and values in the NHS Constitution are adopted, supported and applied to CYP.

Emma presented information on a GP Champions project – a partnership project between AYPH, Youth Access and the Royal College of General Practitioners (RCGP) Adolescent Health Group.

There are 10 pilot sites - with partners across general practice, the voluntary sector and young people.

The partnerships are proving successful, and several initiatives underway. They have enabled young people to say what they want from their GP and members of the practice team.

Following completion of the pilots, there will be a Learning launch held in March 2015 and 'Toolkits' developed.

Network for Designated Professionals

PiP is working with Geoff Debelle, Designated Doctor, Eileen Welch, Designated Nurse (Sandwell & City) and Heather Widdowson, Designated Nurse (South Staffordshire) to re-establish this Network.

The key objectives are to:

- Provide clinical leadership to local child safeguarding systems
- Provide a consistent, strategic approach to child safeguarding in the fields of assurance, training, supervision and the provision of advice and support
- Provide peer support

A workshop was held on 25th September 2014, with presentations from:

- Helen Hipkiss Regional Lead for Safeguarding
- **Geoff Debelle** Supervision within Safeguarding
- **Helen English** Safeguarding aspects of non-therapeutic male circumcision".

Those present prioritised areas of work:

- Supervision and peer review
- Defining the role of designated professionals in the current climate, and in the light of the fact that the NHS assurance & accountability framework is in the process of being rewritten.

These work streams are being taken forward:

- Child Sexual Exploitation (CSE)
- Role of the Designated Professional
- Role of the named GP
- Supervision and peer review
- Non-therapeutic male circumcision

General Paediatric Surgery project

This is a joint project between BCH, PiP and the SCN. The Clinical Leads for the project are Mr Oli Gee (BCH) and Mr Doug Bowley (HeFT).

The project aims to create a defined framework for a credible and sustainable managed clinical network for general paediatric surgery (GPS) and urology across the West Midlands.

The Project Board continue to meet - last meeting held on **2nd December.**

A Stakeholder event was held on **17th July** with representation from clinicians and commissioners.

A CPD event was held on **20th November.** This was successful, with only a small number of providers not represented. A representative from the Royal College of Surgeons attended.

Members of the network would like to meet every six months for CPD and to discuss network business.

It is anticipated that Providers will undertake a 'self-assessment' against the RCS Standards.

Commissioning guidelines for two GPS procedures are due to be published soon.

National guidance on several areas in relation to the provision of GPS is expected in the next six months, which will directly influence the work of the network.



The Strategic Clinical Networks are currently being 'realigned'; within this context it is important that we continue to work collaboratively - to identify 'gaps' in service provision and to ensure there is no unnecessary duplication of work.

Paediatric Clinical Guidelines

Andrea Read is progressing the NICE accreditation process.

The Guideline development process for developing the Paediatric (and Neonatal & Obstetric) Guidelines has been improved to meet the criteria set out by NICE, and has now been submitted for assessment.

It will now go through the NICE accreditation process and the decision is expected in March 2015.
